About the Seminar:

The National Education Policy 2020, the first education policy in the twenty first century and approved by the Indian Union Cabinet in July, 2020, brought many changes to education system, especially from school to higher education level. Promoting multidisciplinary education and the ethical values of our Indian society, it tries to enhance students' conceptual understanding and critical thinking and gives emphasis on the creative potential of each student. It promotes holistic multidisciplinary education with multiple entry and exit options to increase the Gross Enrollment Ratio (GER). The distinct fact about this policy is that there is no hard separation between arts and science, curricular and extra-curricular activities and vocational and academic streams. It focuses on the innovative teachers training, reforming the existing exam system, childhood care, use of technology, vocational education, adult education and so on. The mother language will be the preferred medium of instruction in this policy. This policy clarifies that the centre and the states will work together to strengthen our education system. The seminar shall focus on the implications of implementing NEP 2020 at the Under Graduate level. While the 5+3+3+4 structure which covers the 12 years of a student's school-life journey has been much talked about, it is high time that we discuss the wide variety of possibilities that NEP 2020 offers at the Under Graduate level. Students, studying at the Under Graduate level can complete their desired courses in either 1,2,3 or 4 years under this policy of education. This will be a model of education which will be able to accommodate Certificate Courses, Diploma Courses, Degree Courses and Research, into one frame, one system and one institution. Students coming from diverse socio-economic backgrounds and having diverse talents and potentials can benefit from such a policy of education. The multiple entry and exit opportunities will make the system more flexible and more understanding towards students' need and demands. Though it advocates several policies and has many advantages to improve our education system, it is difficult to implement such policies in a multi-cultural, multi-lingual and multi-dimensional country like India. Hurdles such as the infrastructural shortcomings, lack of economic sustenance and constraint of time will pose a lot of challenges to the successful implementation of the NEP. Along with investigating the obstacles, the seminar will try to offer possible ways and plans to overcome them.
